The manufacturer must submit a completed Form 36W for each qualification, along with group B raw data. Group B testing shall be performed at an approved test facility. If the manufacturer has no certified production in the reporting period, the manufacturer must indicate this on the completed Form 36W. The manufacturer shall submit the retention report to the National Quality Assurance Representative for review and coordination. A copy shall be submitted to this Center by July 1 of each year. We reserve the right to request evidence of the manufacturer's capability to produce QPL printed wiring boards as stipulated by paragraph A.4.5.5 of MIL-PRF-55110G w/Amendment 3.

This qualification listing is valid through the expiration date indicated by the last 6 digits of the qualification reference numbers (mmddy), provided that all requirements of the subject specification are met. Manufacturers are required to inform our office within 3 business days if a failure occurs during group B testing, if production of certifiable product is discontinued, or prior to issuance of a GIDEP Alert and/or Problem Advisory on their QPL products.
